Eligibility	 Participants must be enrolled in, and in good standing with, a Virginia private school that is a member of VISAA Division II (Less than 160 boys or less than 160 girls in the student population, grades 9-12). Participants must have swum in at least half of the schedule meets with their team during the season 8th graders who meet the above criteria are eligible to score There will be no exhibition-only swimmers, however, if a swimmer is officially entered in one individual event, they may swim in one other individual event as exhibition. Per VISAA rules, 7th graders are not eligible to compete. No swimmer may swim more than 4 total events, with no more than 2 individual events. Divers that are also swimmers many compete in one (1) extra individual swim event as "exhibition".
